



This contract is for the driving instruction at Malverne High School during the school year and summer September 1, 2022 – June 30th, 2023 a minimum of 25 students per semester. The roadwork will begin and end at Malverne High School (see course start and end dates per application).

Bell Auto School, Inc. agrees to provide the behind-the-wheel laboratory portion of the Driver-training course at \$375.00 per student for fall 2022 and spring 2023 for 16 (1 ½ hour sessions). This price is based on the current range of current fuel charges. In the event fuel prices exceed \$4.50 per gallon, an energy surcharge increase for the price per student will be agreed upon by both parties.

The quoted price includes all costs of the contract vehicles (gasoline, insurance and repairs) provided and used by the employees of Bell Auto School, Inc. Bell Auto School, Inc. agrees to work under the supervision of the Malverne Union Free School District. Bell Auto School, Inc. will follow the approved outline for instruction as designed by the Coordinator. Each Student will receive a minimum of 6 hours of behind the wheel instruction and 18 hours of in-car observation.

Bell Auto School, Inc. agrees to provide properly licensed instructors in accordance with the Department of Motor Vehicles. The Driving Instructor will follow the policies and procedures of the High School. Bell Auto School, Inc. agrees to provide late model vehicles that are dual controlled, and safety equipped in accordance with the Department of Motor Vehicles. All State regulations for Driver Education cars must be met. All vehicles will be properly maintained with detailed service record.

Bell Auto School, Inc. agrees to complete all attendance and progress records required by New York State law. Mandatory liability insurance must be provided by Bell Auto School, Inc. A Certificate of Insurance must be provided prior to commencement of semester.

Bell Auto School, Inc. agrees to the attached detailed specifications. Any contract agreed to under this agreement is subject to termination by either party with thirty days written notice. In the event of termination of the contract, the District's responsibility shall be to pay for unpaid services performed to the effective date of termination, and such payment shall constitute full and final payment for any contractor claims. In the event of termination, in order to protect the continuity of the District's operation, the required services may be procured from the proposer with the second highest score at the second proposer's original pricing, or from other sources upon the mutual consent of both parties. This Agreement shall be void if the New York State Education Department does not grant approval to the District's application for a Driver Education Program.
